# **Approval Last Meeting Minutes**

## **Presentation of Reports**

- 1. Financial
  - a. Bank accounts. We now have 3 accounts:
    - i. The majority of operating funds are in a high interest account.
    - ii. A prudent reserve for operations is in our normal business checking account. This is where we pay bills from.
    - iii. We keep \$500 in a separate "petty cash" account linked to the debit card.
    - iv. The DNI Accountant rebalances our cash monthly.

Full Financial Report- Feb 2023

- 2. **Trees** we have spent 61% of our budget for forest maintenance (both scheduled and unscheduled).
- 3. Capital Improvements Streets/Curbs/Gutters
  - a. U City scheduled to award street maintenance contracts 18 Apr 2023.
  - b. U Park will be eligible to contract these vendors for the same unit price as the city will pay.
  - c. Next steps: receive and approve short form contract with Horner & Shifrin for developing a 5-10 year capital improvement plan and developing the scopes of work and oversight of projects for FY 2023. Expect a draft proposal from H&S by 24 Mar 2023.

## Old Business

- 1. **Maintenance Garage (aka "The Shed").** We are actively working on a use agreement with U City in Bloom (UCIB) to use the former maintenance garage at the end of Pennsylvania..
  - a. The UCIB board approved entering an agreement to use The Shed.
  - b. The U Park attorney is drafting a lease agreement which will charge UCIB a nominal rent in exchange for them beautifying the shed lot.
  - c. Trustees must confirm the water meter has been installed and water is on prior to lease signing.
